## AGENCY OF THE PUBLIC PROSECUTOR'S OFFICE AND CIVIC COURT



The Authorities of the Wholesale Market of Mexico City have encourage those people who have been victims of crime to file their complaint to the Public Prosecutor, since it is the only defense they have to set off the whole machinery of the procurement and administration of justice, and without it can not be a preliminary investigation that allows complete the criminal action, if necessary.

In addition, they are not only informed of the procedure to be followed but are also accompanied to the Agency 60 of the Public Prosecutor's Office, located in this wholesale center to submit it, because it is a mat-

ter of sensitizing traders and users who have suffered a offense against their person, property or legal area to go before the authority and initiate the process of delivery of justice.

The Public Prosecutor's Office has two ways to prosecute a crime: the denunciation and the complaint of the affected party. The difference is that the complaint is presented directly by the affected party in case of simple crimes and there may be legal pardon and settlement between the parties; while the denunciation can be presented by any person, and there is no agreement between the parties.

After the body of the crime is integrated and the probable responsibility is credited, the Preliminary Inquiry is made available to a judge; that is, criminal proceedings are brought about and the process of Justice to determine whether the person who was submitted to the authority, is guilty or not.

## **TO SUBMIT A COMPLAINT, WHEN THERE IS NO DETAINED PERSON**

- Go to the Public Prosecutor's Office, or do it online
- Present an identification document
- Request the unique format for the complaint
- Fill the format with clear and readable letter
- Write a summary of the events that motivated the complaint
- Sign or stamp your fingerprint
- Subsequently staff will write in the complaint the number of the Preliminary Inquiry and certify the document
- You will be given a copy of the format and / or a certified copy, after payment of rights, so that you can save it for your record
- You will be given a date and time to show up again to ratify your complaint
- In your case, you will be interviewed by the Investigation Police to provide more data for the process

## **TO SUBMIT A DENUNCIATION WITH A DETAINED PERSON**

- When someone from the Auxiliary, Preventive or Investigation Police submit a detained person to the Public Prosecutor as the perpetrator of a criminal offense, the elements must submit their statement, as well as the recovered objects, which may be weapons or other things, in case of robbery
- Subsequently the victim or the offended person submits a statement, with the report of the facts
- If it is a robbery, the victim is asked to demonstrate his property of the recovered object and he can do so with a document that guarantees such property or by presenting witnesses to confirm it
- According to the type of offenses and the circumstances in which they occur, the intervention of valuation experts will be required to assess the value of the stolen object
- All the data that is necessary to integrate the Preliminary Inquiry will be required from the person who submits the complaint
- You are also asked to indicate whether there were witnesses to continue the procedure

## **CIVIC COURT**



In accordance with the Civic Justice Act for the Federal District, in its article 8 it states that are civic offenses, among other, the following:

- Produce or cause noise by any means that is notoriously against the tranquility or health of people
- Urinating or defecating in unauthorized places
- Throwing, dumping or abandoning dead animals on public roads, waste or objects not hazardous to human health
- Enter the areas duly indicated as restricted access in public places, without the corresponding authorization
- Allowing minors access to places to which it is expressly prohibited for them
- Damaging, mistreating, dirtying or making improper use of facades of public or private property, statues, monuments, posts, buttresses, traffic lights, mailboxes, water intakes, road or works signs, squares, parks, gardens or other similar goods
- Invite or practice prostitution
- Drinking alcoholic beverages in unauthorized public places
- Consume, inhale, aspirate narcotic or psychotropic or poisons or toxic substances
- Throwing wastes, dangerous substances for the public health into the street or substances that give off unpleasant odors
- Detonating or lighting rockets, pyrotechnic games, bonfires or lifting aerostats, without permission of the authority
- Produce false alarms for emergency services, police, firefighters or medical or welfare facilities, public or private
- Waste water or prevent its use to those who need to access to it in pipes, tanks or storage tanks, as well as misuse of public fire hydrants, obstruct them or prevent its use
